Handicap parking: Handicap parking is available, with full hook-ups, but it is a good distance from the main group parking.





Golf cart for your rally site: If you want your own personal transportation around the rally site area, you can rent a golf cart for \$45/day. The rally team will be renting at least one golf cart throughout the week, which may be all you will need.



Extra-early arrivals: As noted in the registration form, you can arrive up to three days early (October 5, 6, 7) at a cost of \$35.75/night, and those nights are to be paid to DOAI as part of the registration. Any reservations for arrivals before October 5 are to be made directly with Bethpage Camp-Resort at a rate of \$39/night plus tax. The telephone number is 804.758.4349.

Thetford Corp. issues new Norcold recall

It is important to implement this safety enhancement to prevent an unsafe elevation in the temperature of the cooling unit should the unit fail in operation. This enhancement seeks to minimize the risk of injury or death due to fire.

Norcold Inc. has decided to recall certain 1200, 1201, 1210 and 1211 model gas/electric refrigerators with serial numbers from 315525 to 13088811, non-consecutively. The refrigerator's model and serial number are located inside the fresh food compartment. These refrigerators may have cooling units with a cooling unit serial number between 700000 to 13085759. This is a **new** recall campaign to include all 1200, 1201, 1210 and 1211 models.

Even if your refrigerator was repaired as part of a previous recall, it is necessary to have it repaired again to minimize the risk of injury or death due to fire.

If you have one of these refrigerator models, use the following procedure:

1. Identify and write down the refrigerator model. If it is a Norcold 1200, 1201, 1210 and 1211 model, go to step 2.

- 2. Identify and write down the refrigerator serial number. If the serial number falls in the range of 315525 and 13088811, go to step 3.
- Identify and write down the cooling unit serial number. If the serial number falls in the range of 700000 and 13085759, go to step 4.
- 4. Call your dealer immediately.

The installation of the High Temperature Sensor will be at no cost to you.

Owners of recalled refrigerators **should not** operate their refrigerator until it can be professionally repaired by your dealer or a Norcold authorized service center.

If you have one of the recalled refrigerators and you currently reside in the RV, you should immediately:

- 1. Set the refrigerator controls to "OFF".
- Unplug the refrigerator through the service vent on the outside of the vehicle.
- Contact your dealer, a Norcold authorized service center or Norcold's Recall Center at 800.767.9101 as soon as possible to get assistance.

If you have one of the recalled refrigerators and you do not currently reside in the RV, you should immediately:


- 1. Set the refrigerator controls to "OFF"
- 2. Unplug the refrigerator through the service vent on the outside of the vehicle.
- 3. Disconnect from shore power.
- 4. Contact your dealer, a Norcold authorized service center or Norcold's Recall Center at 800.767.9101 as soon as possible to get assistance.

Failure to follow these instructions can result in a fire causing injury or death.



Find the cooling unit serial number.

Remove the refrigerator's intake vent cover on the exterior of the vehicle. The cooling unit's serial number is in plain sight on the unit's lower right as shown here.



Serial numbers subject to recall:

Two-Door Models:

N621, N641, N821, N841 & 1082 Serial Numbers 1038000 to 1099000

Four-Door Models:

1200, 1201, 1210 & 1211 Serial Numbers 700000 to 13085759

Take the next step.

If your refrigerator serial number and cooling unit serial number falls within the appropriate range:

- 1. Call your dealer immediately, or
- Find a dealer near you and call immediately, or
- 3. Call 800.767.9101

2013 is an election year for DOAI

Although all positions are up for election, the following positions will not have an incumbent, and it is particularly important for the nomination committee to find qualified candidates willing to serve in these positions:

Vice President of Development
Secretary
Treasurer
Vice Treasurer
Northwest Region Vice President
Southeast Region Vice President
Southwest Region Vice President

We need your input to find candidates. If you are interested or know someone who would consider serving on the board, please contact me or your region vice president. Contact information is provided on **page 10**. You must live in the region in order to serve as the region vice president. In the case of members who live full time in their Discovery, this definition does not necessarily mean legal resident, but the area where they spend most of their time.

Here is the 2013 time line for elections:

- August 15 Slate of nominees submitted to board of directors for approval.
- October *Discovery Express* -This edition will contain a hard copy of the ballot (for those who do not wish to vote electronically) and brief biography of each candidate.
- October 15 Electronic voting opened for members to cast ballots online.
- November 20 Final date to receive mailed ballots and final date for electronic voting.

In the past, we have had a single candidate for many positions and a very low percentage of our members who cast ballots. Most of you agree we have a great owners' association that provides real value to its members. It is essential for the future of our association to have folks like you step up and serve. Many board position duties require only a small amount of time. Please contact me if you have any questions.

Quilts being created for 2013 national rally

The quilts are underway! Immediately upon concluding the 2013 southeast region rally in Florida, the 2013 quilt group got to work. During the coming months, there will be ladies across the country choosing fabrics, cutting pieces, threading up the sewing machine, stitching away, and shipping their creations on to the next person – all in an effort to create two beautiful quilts for the 2013 national rally. One quilt will be king size, the other will be queen size.

This tradition began at the 2005 DOAI national rally in York, Pa., and since then there have been some exquisite quilts won by deserving DOAI members at national rallies. The funds raised through the efforts of the DOAI ladies have benefitted a variety of agencies that help others through training service dogs, sheltering victims of domestic violence, helping communities come back from catastrophic flooding, assisting our veterans, and lending a hand to disadvantaged children and families, to name a few.

The quilt themes this year reflect the location of the rally: one pays homage to the Blue Ridge mountains and the other features the Liberty Bell in recognition of the many American Revolution sites in the area. The beneficiaries of the event will be announced later this year.

Computer corner

Cloud computing

What is it? Cloud computing is a term for using an Internet service to store or process data instead of your personal computer.

Relatively recently, there has been an veritable firestorm of companies offering to store and/or sync your data or offering computing services such as word processing

or spreadsheets. Let's explore how the average RVer can use these services, usually for free.

Free services are available (Google Drive, CloudOn) that allow you to run Office-type software in the cloud on your mobile device, or even your desktop – no need to buy expensive software. Most RVers probably don't need this service unless they need to open a document and don't have the proper software, so I will concentrate on cloud storage/sharing.

Mobile computing is transitioning to devices with small data storage and this storage is made up of memory chips called a Solid State Drive (SSD). The reason for this is speed (an SSD is **much** faster than a traditional spinning hard drive) and greatly reduced power and space requirements. The downside is that SSD's are expensive.

Laptops with an SSD typically have only 90 GB or less storage for the user. This certainly is not much room for pictures, videos or programs. Tablets and cell phones have even less storage. Although you can easily add an external drive to a laptop, that is just another device to carry and eventually fail.

There are many services that provide free online data storage such as MS Skydrive (7 GB free), Box (up to 50 GB

free), Bitcasa (10 GB free), Dropbox (2 GB free), etc. There are also specialized services that will store your photos and videos such as Shutterfly, Picasa and Flickr. (I like Shutterfly because it does not resize my photos to a lower resolution.)

I use free online storage services for all my multimedia and documents. All of the service material for my D, and literally all of my paper documents, have been scanned and uploaded. Other than the obvious advantage of not needing local storage space, my documents are available on **any** computer, cell phone or tablet that I own or borrow. In

addition, most services can be configured to keep files in sync, if I choose, on any of my devices.

Although there are many free services to choose from, I have criteria for determining which service/s I use. The service must be in it for the long haul (Skydrive, owned by Microsoft, is a good bet). It must be easily useable on Windows, Mac, iOS and Android. Ideally, all files should be encrypted/ decrypted automatically and locally and not in the cloud. Bitcasa is the only one that meets this last requirement, but you can install FileCrypter or BoxCryptor for easy local file/folder encryption. Since the encryption is done locally, only you have the password to decrypt – just don't forget the password. Now, even if someone manages to hack into my online storage, they won't be able to see anything.

The downside of using these free services is that an Internet connection is required to retrieve your documents. However, WiFi or cellular access is available almost everywhere, so this is not a big concern. In an upcoming issue of this newsletter, I will discuss Evernote, which is a cloud-based service for saving (and retrieving) almost anything instantly.

Dallas writes: "Thanks again to all. I keep telling people how great the DOAI is and how much I learn. I still read the majority of the emails on this site and have saved several. What is really neat is how fast

people respond to Discovery owners' issues. It's almost like having your own personal technical service 24/7.

"We have met several people during RVing, and when I explain the DOAI egroup process, they are all jealous. Several have tried to find similar groups for their motor home models, to no avail. We are so happy that we lucked into owning a Discovery motor home, but more importantly, having the security knowing we have hundreds of people willing to help

with any Discovery issues. I have helped a couple of my friends with tips provided by DOAI that were generic and applicable to any motor home.

"For example, the discussions on using an external surge/power protection device was passed on to a friend who had already spent nearly \$1,000 fixing his coach power after running into a power problem at a small public RV site. He has since installed the surge/power protection device and it has saved his coach on two occasions.

"I have saved hundreds of emails and used several of them in resolving issues with our motor home (none of them major). Just the other day, we had a problem with the bedroom slide not retracting. I calmly looked at all the information I had saved and started working on the problem. I was not stressed, knowing I had this wealth of information and also by knowing the DOAI group could probably help me if the problem was not resolved. Thank you, everyone!"



Sausage Cheese Balls (**Judy Scott**)

2 16-oz. pkgs. regular flavor Jimmy Dean® pork sausage 1½ cups all-purpose baking mix ½ cup celery, finely chopped 4 cups sharp Cheddar cheese, shredded 2 tsp. black pepper ½ cup onion, finely chopped 2 tsp. garlic, minced (optional)

Preheat oven to 375° F. Combine all ingredients in large mixing bowl; stir well. Form into 1" balls. Place on ungreased baking sheet; bake 18-20 minutes or until golden brown. Remove from oven; cool 5 minutes before removing from pan. Serve with cocktail forks or toothpicks.

Dump Cake (Freddie Perry)

1 can crushed pineapple 1 can cherry pie filling 1 box yellow cake mix 1 cup coconut, shredded 1 cup walnuts, chopped 2 sticks (16 tbsp. or ½ lb.) butter, melted

Preheat oven to 350° F. Grease a 9"x13" pan. Layer ingredients in order listed. Bake for 60 minutes.



Corn Casserole (Neva Jardine)

2 eggs

1 box Jiffy® cornbread mix

1 can whole kernel corn

1 can cream style corn

1 small onion, chopped

1 can green chili peppers

1 stick (8 tbsp.) butter

1 small carton sour cream

2 cups grated Cheddar cheese

Preheat oven to 375° F. Mix eggs and cornbread mix; add both cans of corn including liquid and pour into a 9"x13" pan. Sauté onions and peppers in butter. Spread the sour cream and sautéed onions/peppers over the mixture. Cover evenly with the cheese. Bake for 45 minutes. Do not brown the cheese; it will get tough.



Keith Lindholm also posted this comment: "I have finally found a quality portable oil drain reservoir that is perfect for motor homes. It is made of black polyethylene, measures 4.5" in height, and can handle 30 liters of oil (nearly 32 quarts). It has built-in casters for ease of movement, and the low profile makes it easy to get underneath the coach. It measures 23" wide by 33" long and takes up very little room for storage on edge.

"I saw a mobile RV service technician using one while servicing my neighbor's coach, and he gave me the URL where he found it: www.griotsbarage.com. I'm sure this item is available elsewhere, if you search the 'Net. This product, along with a Fumoto oil drain plug with hose barb connection should make future oil changes a nice, clean process."

Bill Stiles chimed in: "One thing I think all of us with Cat engines could use are the offset funnels to fill radiator overflow tanks and window washer tanks, plus other stuff. The funnels are on the same page as the oil drain tank. They are 7" long, and 3" across with a tapered 2" funnel.

RV Education 101

Every RV owner should have a basic understanding of weight terms. Do your research to avoid becoming a statistic in relation to overloaded RVs. Here are the basics you should know:

Mark Polk

Gross Vehicle Weight Rating (GVWR) – The maximum permissible weight of the vehicle when fully loaded for travel including the vehicle, cargo, liquids and fuel, passengers, and any towed vehicle tongue weight. Motor homes, tow vehicles, and trailers all have GVWR.

Unloaded Vehicle Weight or Dry Weight (UVW) – The actual weight of the trailer or truck as built at the factory. The UVW does not include passengers, cargo, fresh water, LP gas, or after-market accessories.

Cargo Carrying Capacity (CCC) – The maximum permissible weight of personal belongings that can be added. CCC is equal or less than GVWR minus UVW, full fresh water weight, and full LP gas weight.

Gross Axle Weight Rating (GAWR) – Every axle has a GAWR. It is the maximum allowable weight that the components (tires, wheels, brakes) of each axle are designed to support.

Gross Combined Weight Rating (GCWR) – The maximum permissible weight of the tow vehicle and trailer combined when both are fully loaded for travel. GCWR also applies to a motor home towing a vehicle or trailer behind it. GCWR minus GVWR represents the allowable weight for the towed vehicle. Note: The hitch receiver mounted on the towing vehicle must be rated for this amount of weight. If it is rated for less, that is the maximum amount you can tow.

Gross Vehicle Weight or Gross Trailer Weight (GVW), (GTW) – This is not a rating; this is the actual weight of the tow vehicle or trailer when they are fully loaded for travel. This includes the vehicle, cargo, liquids and fuel, passengers, and the towed vehicle's tongue weight.

Hitch Weight or Tongue Weight (TW) – The amount of weight pressing down on the vehicle's hitch or fifth wheel connection when the trailer is fully loaded for travel.
