INTENT: Make revisions to Article III - Membership / Section D - Fees and Dues. The two (2) proposed revisions are:

- 1. Reduce the delinquency grace period from the current six (6) months to 30 days and add a timeframe for activation of this change in Section D-3.
- 2. Add wording to indicate that any dues payment for expired dues will have the new dues expiration date set to the date the reinstatement dues payment is received.

The currently proposed wording for the motion is listed below.

<u>D-2: Reinstatements</u>: Reinstatement of any former member of DOAI who resigns while a member in good standing may be received again into membership with the original DOAI number, if the following items are met.

- Upon application and payment of only the current year dues (i.e., without payment of initial fee).
- All other membership requirements must be met.
- The member's due date will be reset to the date the dues payment is received.
- <u>D-3. Delinquencies</u>: Any member whose dues remain unpaid for more than 30 days after becoming due shall be considered delinquent and forfeits membership in DOAI.
- This delinquency grace period takes effect at the implementation of the new system.

# **MOTION #2**

INTENT: Make a revision to Article III - Membership / Section - Application Process. The proposed revision is:

• Change the wording in Section C-1 that an application and dues be 'mailed' to be a more generalized wording for applying for membership and paying dues.

The currently proposed wording for the motion is listed below.

# <u>C-1. Application Process</u>: An applicant for membership shall complete a DOAI application and pay the associated dues by any DOAI offered and available options.

#### MOTION #3

INTENT: Make a revision to Standing Rule #2 - Membership Dues and Fees / Section C - Non-payment of dues. The proposed revision is:

• Deletion of Section C-1 since receipt of the DOAI newsletter is a benefit of having an active DOAI membership, the direct mention of receiving the newsletter is a redundant Standing Rule entry.

# C-1. Non-Payment of dues: COMPLETE REMOVAL OF C-1 from Standing Rule #2



# Ohio, So Much to Discover

The Midwest Discoverers and Noreaster Discoverys Chapters are looking forward to sharing the history, scenery and entertainment opportunities of western Ohio with our members. Greenville is located on the Ohio and Indiana border. It is about 90 minutes from Columbus, Toledo, Cincinnati and Indianapolis. It is less than an hour to Dayton and a little over an hour to the REV RV Service and Repair facility in Decatur, Indiana

History lovers will be overwhelmed with the variety of areas of historical significance in the area. The Garst Museum houses numerous exhibits that highlight the life of America's early pioneers and the role this area played in the opening of the Northwest Territories to settlement. It is also the home of the National Annie Oakley Center. Nearby Fort Recovery is the site of two of the most dramatic Indian battles in American history and is only about 30 minutes from the fairgrounds.

Numerous sites in the area celebrate Ohio's role in aviation history and space exploration. Take time to check out the Armstrong Air and Space Museum in Wapakoneta, OH. The facility honors hometown hero Neil Armstrong, the other astronauts who call Ohio home and all pioneers who have made air and space exploration possible including artifacts from Soviet Cosmonaut Yuri Gagarin, the first human to go to into space.

We hope that you will join us on one or both of our scheduled bus tours. On Tuesday, September 19 we will visit the National Museum of the US Air Force near Dayton, Ohio. It is the oldest and largest military aviation museum in the world. Thursday, September 21, will find us exploring Carillon Historical Park. It's 65 acre campus was designed by the Olmstead Brothers, the famed landscape architects of Central Park. The Park showcases Dayton's rich heritage of creativity and invention including the airplane, automobile self-starter and the cash register. It is home to over 30 historic structures, a hand carved carousel, an exquisite 151 foot carillon, trains, locomotives and living history exhibits with docents in period appropriate attire providing additional information, anecdotes and historical context. The John W. Berry, Sr. Wright Brothers Aviation Center is housed here and includes extensive Wright artifacts including the 1905 Wright Flyer III, the only airplane designated as a National Historical Landmark. It is a fully operational brewery, and has the distinction of being the only brewery housed in a museum in the county.

For those looking for adult beverages, the Whiskey, Wine & Ale Trail is worth exploring. Antique lovers will enjoy numerous shops in the area. For those interested in exploring the outdoors, there are over 10 miles of hiking trails, 14 miles of biking trails and 6 miles of water trails.

Back at the Fairgrounds Rally Hall, there will be lots of social activities along with technical seminars. BYOB Happy Hours will be held nightly. We will kick off the Rally with a welcoming Pizza Party followed by some musical entertainment. This is a great opportunity to meet and greet your fellow rally attendees. You can look forward to more catered dinners and entertainment along with a Pot Luck supper.






