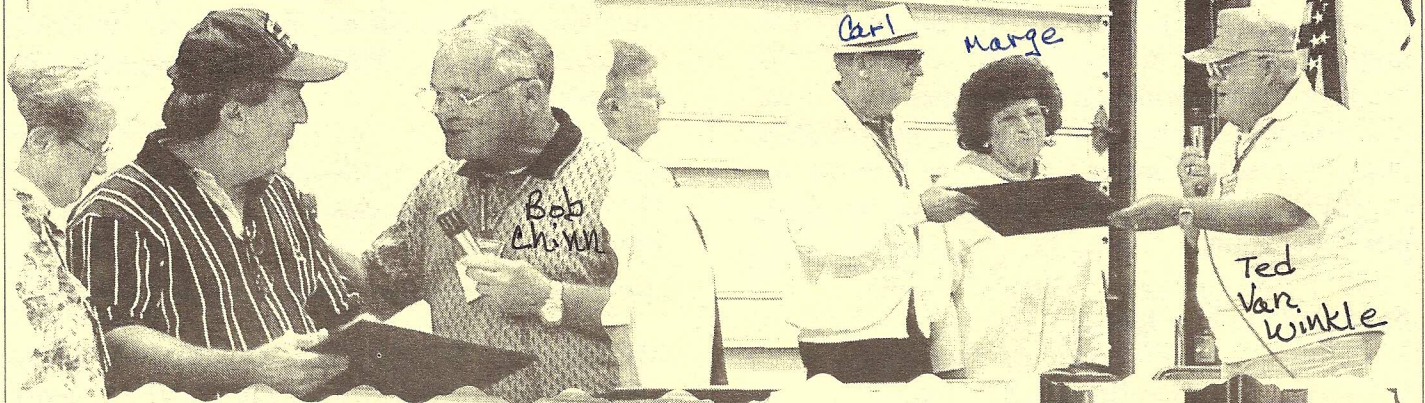
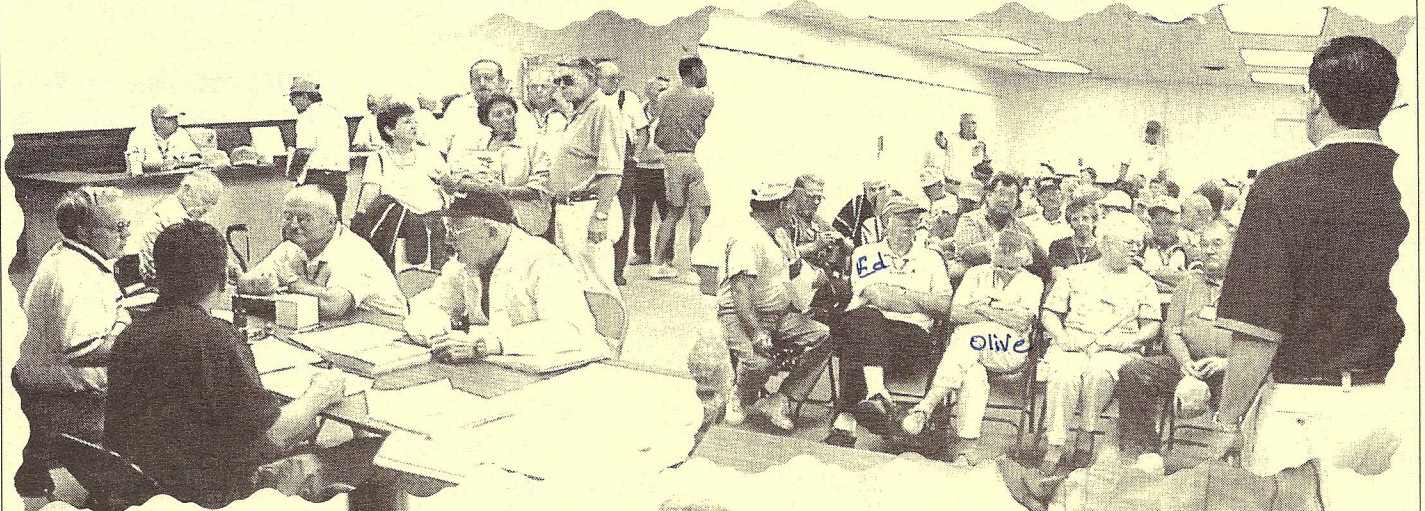

DISCOVERY TIPS & HINTS

Fall is almost here, though right now it seems too hot to believe it. Depending on your plans it is time to get the furnace tuned up for cold weather or the coach winterized for storage.

How long has it been since you looked through your owners manual? This isn't a silly question. We find it a valuable source of information taken along with a pinch of common sense. I get a lot of questions on a daily basis and use the owner's manual for a refresher along with my service experience to come up with the answer. A lot of people tend to get offended when asked the question "Have you read your owner's manual"? I don't and you shouldn't either.

What's my point? Back to the original comments, it is either time to get your furnace ready for the colder months or prepare your coach for storage. Much of the information needed to accomplish this can be found in your owners' manual.

I was recently asked a question on winterizing, and I went into what I thought was great detail in the answer. I detailed the wet (with antifreeze) method and the dry (using air to blow out the lines) method and thought I covered all bases. Then I looked into an owner's manual. It is amazing how much I missed. No one can remember everything.

This brings me back to my point; use your owner's manual as a resource. I recommend attaching a sheet of paper or using the margins of your manual to add notes. What should you write?- the little things that we all tend to forget, and the specific things that your coach may be equipped with. The icemaker in the fridge, the washer dryer, the P trap behind the washer dryer and anything else out of sight or mind are good examples. In the section "Motor Home Storage" there is a series of checklists for short-term, long-term and winterization. As I reread the section more and more came back to me. I had forgotten all about the chassis and many of the appliances that have specific needs. Test your self, try to think about as many areas that need winterizing or

storage maintenance and then read the manual. If you are really good and get 50% of the items or more, congratulate yourself. If not, then the time spent reading the manual was not wasted. Test yourself again next year.

About the furnace, operation at periodic intervals can be the best maintenance. Every year we hear the same complaint, my furnace doesn't work! We ask how long it has been since it was used and receive answers like last winter or never, it's new.

With furnaces it is better to use them well before you need it or be prepared to endure the smell of the furnace when it lights off for the first time of the year. New furnaces and ones that haven't been used in quite a while can smell very **bad**. **This is normal**- the smell is caused by the dust that may have settled on it or the paint on the burner chamber if it is still new. We like to open all of the windows and the entry door and let the furnace go through the burn off so we can avoid that first use of the season smell. The other benefit of this is to have ample time to have the furnace serviced if it isn't working properly. Don't wait until you are all packed or on the road to find out if the furnace is working. It could make your trip a cold one, and we don't want that, do we?

What kind of maintenance does the furnace need? Read the manual that came with it. Cleaning the blower wheel and making sure that intake and exhaust vents are clear is a good place to start. Some areas of the country have mud daubers that like to build nests in furnaces. Frequent operation makes this less likely. If it does happen you may hear the noise of the nest spinning around in the burner chamber, or it just may not work at all if it is plugged up. If this happens it is time to take the coach to a dealer for service. The furnace will have to come apart for a thorough cleaning.

Checking all of the vents for accumulated debris is another good thing to inspect. I have had the opportunity (unfortunate) to clean out and replace a duct hose that became home to a family of rodents. Not a pretty picture. And even more of a reason to test the operation before it gets cold and you really need it. The owner didn't find out about the rodent nest until the furnace was fired up

at a rally. The symptoms were low airflow and a very bad smell.

Another hot tip (pun intended) is to use the dash heater when preparing for a night of dry camping. The idea is to allow the engine alternator to top up the batteries state of charge while using the heater to warm up the coach. This will delay the first cycle of the furnace for a while. The length of time will depend on how cold it is outside.

Keeping your LP tank full also helps your furnace operate better in very cold weather. The level of LP is important because in cold weather it is harder for the LP to change from a liquid to a vapor. It requires heat from the outside to transfer to the liquid inside the tank and cause it boil off into a gas. A full tank has a larger wetted area inside the tank and results in more BTU's available for use. A tank that is low on LP may not be able to provide enough BTU's for furnace(s) operation in very cold weather.

Owners that use their coaches throughout the winter months often keep the coach plugged in

and the furnace left on and set to the lowest temperature so the coach will always be ready for the weekend skiing trips. This may or may not work for everyone, in some areas where it is very cold it may require setting the furnace to a higher temperature. There is always the risk of freezing when operating at or below 32 F.

Another tip is to keep the water system dry and use water from jugs for drinking and cooking. Use someone else's lavatory for everything else and with this method you won't need to keep the furnace on. And with nothing in the tanks or lines to freeze, this method will work in the coldest of climates.

The best advice may be to talk with other owners that have a lot of experience in cold weather camping, or contact a Dealership or service center located in a cold area.

THE RIGHT FRONT PROTECTION UNIT

When placing my factory order for the Discovery, I made it a point that I did not want the front bra option, thinking there would definitely be no problem whatsoever in ordering a high impact-resistant protective front shield or guard. Also, past experience has taught me that front bra's will and do create more problems than simply providing protection. Well, shopping for the elusive shield, for a Discovery coach, became a major project of three years.

The major manufacturers were really having a serious problem the few Discovery installations on the road and did not want to install any more, so there was a hold. The problem stemmed from the skin section, where the shield was attached to the skin. It was pulling loose due to road vibration, thus tearing the skin and elongating the attaching screw holes. Before a damaged coach got back to the manufacturer's shop, the front became a mess and the shop had to fully repair the complete area of the coach. They refused to install another shield, even without any warranty. So, back to square one! After about four months of problems, they found that the front skin of a Discovery was too thin walled to support a rigid guard of any kind.

I looked into 3M's Invinca-Shield, an invisible film with UV inhibitors that is installed over the base coat of the coach like dark window film. After much soul searching, I rejected this type of protection due to the special graphics on the front of my coach. So, back to square one again.

Well, lo and behold, I met Dean Huges of Progressive Creations, Inc., the makers of Coach-Gard. I explained my problems. Dean measured my coach inside and out, took photos and called his shop staff. He came to the conclusion that a Coach-Gard could be designed that did not require drilling holes in my coach front. Also, he wanted a challenge and opportunity to do his firm's first Discovery coach installation.

We set up an installation appointment at his shop in Mesa, AZ. Early in the morning so his crew would have some extra time to refine some of their measurements and findings. After three

hours, Dean and myself were on the road testing the shield installation. It came through with flying colors!

The guard is made with GE Lexan 1/4" polycarbonate material and is aerodynamically shaped to divert air stream. It does not touch the front of the coach, but gives full frontal protection of the rig. Also, it is hinged for easier cleaning of the front coach skin and access to the rear of the shield. It is great protection and it also looks sharp.

I have been stopped many times by other Discovery owners and even some other coach manufacturers, asking where and how I obtained my Coach-Gard, how was it performing and was I totally satisfied? Needless to say, I am very happy indeed.
